Short Term Fosters need to be available for urgent situations and temporary needs such as holidays, vacations, or returns. Medical Fosters will be fostering greyhounds that have medical problems, who would not thrive in a kennel environment. These might include heartworm positive dogs, lameness, or broken bones coming straight from the track. - _____ I agree that my foster greyhound shall be kept as an indoor family pet in a safe and clean environment and shall be exercised on lead or in a completely secure fenced area at all times and not, at any time, be allowed off lead when outside a completely fenced area
- _____ I agree that I will regularly make my foster greyhound available to attend scheduled activities in order to expose my foster greyhound to potential adopters
- _____ I agree that I will allow my foster greyhound to be viewed by any potential approved adopter with a 24 hour notice
- _____ I agree that my foster greyhound shall not reside in a location other than that specified on this agreement and I will not transfer possession or custody of my foster greyhound to any other person at any time (except for purposes such as vet care, grooming, etc.)
- _____ I agree to contact Nittany Greyhounds, Inc. with new contact information should it change during the period of time covered by this agreement
- _____ I agree to contact Nittany Greyhounds, Inc. if at any point I cannot or do not want to continue to provide care for my foster greyhound and arrange for surrender of my foster greyhound
- _____ I agree that I will notify Nittany Greyhounds, Inc. immediately if my foster greyhound becomes ill or injured, requiring medical care
- _____ I agree that to be reimbursed for medical care of my foster greyhound, the same care must be authorized by Nittany Greyhounds, Inc. prior to incurring any expense except in situations when seeking approval may jeopardize my foster greyhound's life
- _____ I understand and acknowledge that Nittany Greyhounds, Inc. cannot guarantee or be held responsible for the health, behavior, or temperament of my foster greyhound and I expressly release and hold harmless Nittany Greyhounds, Inc. from any and all liability for loss, injury, or damage caused by my foster greyhound to any person or property and that I will assume any such risk of loss
- _____ I understand that many greyhounds are not small dog or cat tolerant and that my foster greyhound may not be safe with other animals or children and I will closely supervise my foster greyhound when he/she is interacting with other animals, regardless of size, or children and will have my foster greyhound wear
