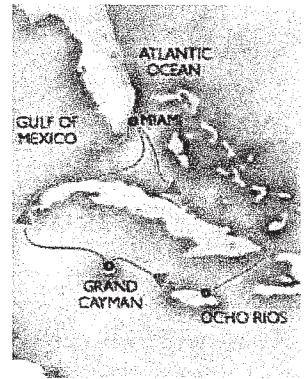

Carnival assumes no responsibility for advising guests of immigration requirements.

Effective June 1, 2009, U.S. citizens traveling on cruises that begin and end in the same U.S. port must show proof of citizenship in the form of a PASSPORT. www.travel.state.gov

Cancellation Policy: All cancellations must be made in writing. Faxes are accepted. We will notify you when we receive your written cancellation. If you do not receive notice from us (SeaFreed Travel) please contact us to confirm receipt of your notice. Travel Beyond will charge a \$50 per person cancellation fee in addition to any cancellation penalties the cruise line charges.

Cancellation and Refunds: If a reservation must be cancelled, the following penalties will be incurred per person:
